Regarding the indicated fluctuations, the Company clarifies that it is not aware of a specific fact that occurred in such period and that is related to the Company that justifies the last fluctuations recorded with its shares, nor with the number of trades and quantity traded, in the period between 07/30/2021 and 08/12/2021.

Having made these clarifications, the Company believes that such variations may result from the disclosure of the Company's financial information for the 2nd quarter/2021 (duly disclosed on 07/29/2021), as well as from the disclosure of quarterly financial information of other companies operating in the same sector of the Company, occurred in the same period indicated in the Official Letter.

Finally, the Company reiterates its commitment, under the terms of the applicable regulations, to keep its shareholders and the market in general informed of any material fact or fact related to its business.
